EITP Says Goodbye to Ted Burke and Welcomes Susan Connor as its New Director

After 21 years of working in the Illinois Early Intervention System, **Ted Burke** will be leaving Illinois and moving to Hawaii where he will be starting in a new role as Director of Early Intervention Programs for Easter Seals Hawaii overseeing programs on the islands of Oahu, Kauai and Hawaii.

Ted served as Director of the Early Intervention Training Program (EITP) since 2002 and has said of his departure, "As exciting of an opportunity as this is, it has been one of the most difficult decisions of my life because of the amazing colleagues and friends I've gained since moving to Illinois over 20 years ago. The relationships I have had with so many of you have shaped who I am today both professionally and personally on so many levels. There are not enough words to express the gratitude I have for all of you who taught me, mentored me, counseled me and stood alongside of me as a part of this amazing journey we call early intervention."

In reflecting on his years working in Illinois' EI System Ted stated, "The positive impacts that I have witnessed for the hundreds of thousands of families that early intervention providers have supported in the past two decades go well beyond the time they spent in early intervention. I believed in 1992 and I believe just as strongly today, that providing support for families during those critical early years has a greater impact on both that individual family and society as a whole than at any other point we provide services later in a child's life. In my time in this field, I've seen society's perceptions change and possibilities grow for people with disabilities that were unimaginable 20 years ago."

Moving forward, the Early Intervention Training Program is excited to announce that **Susan Connor** has been named its new Director. Susan has worked with EITP since 2005 and has been the Assistant Director since 2013.

Upon hearing Susan's appointment to Director, Ted shared "I have had the opportunity to interact and work with Susan in her various roles as service provider, professional development provider, administrator and parent in the Illinois Early Intervention System since 1997. During this time, Susan has proven to be one of those rare early intervention professionals who is not only knowledgeable, but also organized, efficient and willing to do whatever it takes to get the job done. Her level of understanding of research driven evidence-based practice related to child development and early intervention is unparalleled. Susan exemplifies the qualities of dynamic leadership dedicated to improving outcomes for infants, toddlers, and their families more than anyone I've ever known in my two decades working in the early intervention field. As Director of EITP, Susan will bring the practical experience, leadership, training excellence and the respect and admiration of practitioners, policymakers and state and national leaders in the early childhood field that is rarely found in any one individual in our field. Early Intervention and Child Care: Natural Partners in Natural Environments

Children in early intervention receiving services in child care settings increases each year. Some CFCs report that up to 50% of services are taking place in child care centers. Therefore, working with other early childhood professionals is important in best serving these children and their families. In collaboration with the University of Illinois Office of Public Engagement, Illinois Department of Human Services, and Shatterglass Studios, EITP has created a video to support these partnerships between early intervention providers and child care programs. Safety Considerations for Home Visitors

Research indicates that a main barrier to providing early intervention services is concern for personal safety as well as concern for personal property. As home visitors, we may sometimes enter into environments that could be considered "unsafe." While we are dedicated to serving ALL families of infants and toddlers with special needs regardless of their home environments, it is also important for us to take care of ourselves.

Strategies for taking care of yourself:

- Look for opportunities to reflect on your experiences (Vent!!!)
- Obtain support from co-workers who have experienced similar situations
- Seek out opportunities for professional development to learn strategies for supporting families
- Don't be afraid to ask for assistance with establishing appropriate boundaries
- Seek out access to mental health support as needed
- Have a clear understanding of your agencies' expectations when it comes to fulfilling your job requirements
- Request assistance with managing your caseload to ensure that you don't have all high intensity cases (when possible)
- · Look for opportunities to take a "timeout" or to attend a retreat or celebration of your hard work and commitment to your job

Three New Videos Illustrate Family Guided Routines Based Intervention

Early ACCESS in Iowa in collaboration with the Distance Mentoring Model at Florida State University recently published <u>three new videos</u> illustrating Family Guided Routines Based Intervention (FGRBI). The first two videos show what FGRBI looks like during early intervention home visits, and is narrated by providers and family members who reflect on a number of key strategies and themes. In the third video, a parent offers her perspective on the use of toy bags by home visitors.



A Home Visit with Kris and Kiyah (10:50)

Early ACCESS special education teacher Peg joins Kiyah and her father, Kris on a home visit. Peg supports Kris to embed opportunities for Kiyah to learn and participate in the family's everyday activities such as getting ready for childcare and taking a walk.



A Home Visit with Brandon's Family (7:55)

Early ACCESS speech-language pathologist Alison works with Brandon's parents on ways to support Brandon's language development. The family practices using new strategies during the visit and makes plans to use the strategies throughout the week.



Families Talk About the Toy Bag (2:00)

Brandon's parents discuss the benefits of using their own toys and materials for Brandon's play, rather than toys brought in by an early intervention provider.

We are aware that the learning styles and needs of the 6500+ early interventionists in the State of Illinois are not the same and continue to change. We make every effort, with the resources afforded us, to be as flexible, creative and as innovative and professional as possible to offer quality learning opportunities to early interventionists that are research-based and reflect best practices in early intervention. we do strive to do all that we reasonably can to make opportunities available that early interventionists can benefit from at some point.

So why doesn't the Training Program offer more trainings in_____?

The Training Program typically offers between 150-200 training events each program/fiscal year all over the State. Because over 60% of Illinois' early intervention providers and the families they serve reside in the Chicagoland area we plan 60% of our training events in the Chicagoland area.

Why doesn't the Training Program ever offer training about _____?

Again, your feedback from our Training Needs Assessment factors greatly in the development of our training curriculum. Whether we are developing new curriculum or adapting existing curriculum, the content is appropriate for the early interventionist and will have a focus on the Key Principles of Early Intervention. EITP curriculum goes through a review process before we present it, with Illinois DHS giving final approval.
