Our Mission—to mobilize and strengthen the membership by creating a passion for leadership and advocacy in the interest of our most vulnerable children and families.

The IHSA will be able to assist you in finding a Head Start or EHS program in your area if needed.

What Head Start/EHS Does **Comprehensive Education, Health and Family Supports** Head Start/Early Head Start takes a comprehensive approach to meeting the needs of the whole child and family. This two generation approach supports stability and long-term success for families who are most at risk. Thanks to Head Start's comprehensive services, by the end of the year children have received education, health and nutrition services. Families have been referred to

needed resources.

Eligibility Requirements for Head Start and Early Head Start

- A pregnant woman or a child, aged birth to 5 years old, is eligible if:
 - The family's income is equal to or below the poverty line; or,
 - The family is eligible for or, in the absence of child care, would be potentially eligible for public assistance; including TANF child-only payments, or,
 - The child is homeless, or,
 - The child is in foster care.

Head Start/EHS Program Options

- EHS serves Prenatal and Birth to 3 families
- Head Start serves 3 to 5 year olds and their families
- Program options include:
 - Center based, half day or full day
 - Home based, one home visit per week and twice monthly socializations for parents and children
- Of our 52 IL Head Start and EHS programs, 37 offer EHS services (about 71%)
- Of the 37 EHS programs, 32 offer the home visiting model. Of the 42 Head Start-only programs, 18 offer home visiting as well as center based.

Ideas to Share about HS/EHS

- Head Start and EHS services are free of charge.
- At least 10% of every program's enrollment is allotted for children with special needs.
- 10% of enrollment may be for families over the Federal Poverty Guideline.
- Programs are racially diverse and support both home language development and ELL.
- Parent engagement is the foundation of the program. Parents become decision-makers in the program and advocates for their children.
