EITP Online Training Updates

In response to popular browsers and operating systems ending support of Adobe Flash on 12/31/20, EITP has begun the process of removing Flash from our asynchronous online trainings in Moodle.

Here is what you can expect after the first of the year:

- Easier to use interface
- Accessible on any browser (now use whatever you're used to!)
- Works with mobile devices (tablet, cell phone) in addition to laptops/computers!

What's New with the Family Outcomes Survey!

Improving outcomes for children and families is the central focus of the Illinois Early Intervention Program (EI). To evaluate the effectiveness of EI in achieving family outcomes, all families receive a "Family Outcomes Survey", with questions focused on understanding children's strengths, abilities, and needs and EI's ability to help them develop and learn. Beginning September 2020, all families who exit the system will receive the invitation to complete the survey via text message!

Finding Gratitude for Live Video Visits

In 2020, we've all had to adjust the way we work, which is never easy. With grace, compassion, and innovation, you've been able to grow from this unforeseen opportunity and continue to partner with families in EI to meet their varied needs.

In the spirit of gratitude as we end this unusual year, there is another opportunity to appreciate how far we've come. *Tele-Intervention Has Made*

Me Thankful For (or live video visits as we call it in Illinois) illustrates some reasons to be thankful for the new ways we are connecting with families. Consider reflecting with your peers, families, and other team members on what you all are thankful for since implementing the use of Live Video Visits to connect with one another.

New MFLN Training on Advocacy

The MFLN EI team launched their second asynchronous learning module, *Field Guide to Family Advocacy: Knowledge, Resources, and Supports for Military Families of Children with Disabilities*.

The four-part interactive course focuses on the rights of young children with disabilities in military families, eligibility for special education programs and service for children with disabilities available within military systems, and strategies to support military families as they navigate these systems in military contexts. (Civilian contexts are also shared.) Upon completion of all requirements, you will earn 4.5 EI credit hours!







Technology Support Available for Families in Early Intervention



The Illinois Early Intervention Clearinghouse is pleased to be helping families

receive early intervention services during the pandemic by loaning technology to help families participate in live video visits or telehealth. **Available technology includes:**

- iPad with a data plan (i.e., you are requesting a device for live video visits that also has an Internet plan)
- iPad without a data plan (i.e., you are requesting a device for live video visits; you already have Internet access)
- Hotspot (i.e., you have a device for live video visits but require Internet access)
- Quantities are limited. As items become available we will reach out and contact the next name on the waiting list.

To apply to receive the technology, families can complete the Device Loan Request Form.

State Systemic Improvement Plan (SSIP) Update

During these uncertain times, the support being provided by our system is more important than ever. The Leadership Teams have been working to provide support to those who are directly interacting with families, providing opportunities for knowledge and skill growth while also creating a safe place for reflecting on challenges. While the focus of the SSIP continues to be on family engagement, many of the planned activities have changed.

In addition to the Leadership Team activities, we have continued to refine a practice fidelity tool. We recently solicited input from our performance support workgroup to determine its appropriateness and outline some of its potential uses. We will be sharing information about the tool with the evaluation subgroup in the near future. We will also likely be reconvening our large stakeholder group when we know more about the future of the SSIP and the direction that Illinois wants to take.
